CURRICULUM & INSTRUCTION

SUPPORT FOR STAFF AND STUDENTS

Lincoln Consolidated Schools is committed to providing the needed support for our students. Modifications that we are making as a district include:

- Revising our PLC (Professional Learning Communities) process to ensure high levels of learning for every student
- Focus on MTSS (Multi-tiered Systems of Supports) across the district
- A revised district continuous improvement plan based on data and the needs of our students
- Continued work on creating a guaranteed and viable curriculum through grade level and department collaborative team meetings
- Focused professional learning support for staff based on the district's initiatives and staff's needs

CREATING 'SOCIAL JUSTICE LEADERS FOR CHANGE' IN MICHIGAN SCHOOLS

Equity is continuing to be the lens in which we view all of the work within our district. This will be our second year being a part of "MASA's Beyond Equity" grant which focuses on real issues, lived experiences, and district transformation, and is anchored around student voice and activism. Through small and large group discussions, structured exercises and protocols, readings, videos, reflective journaling, and group presentations to share learning and implementation plans, we are continuing to improve our practice. This year, our focus will consist of:

- An equity audit
- An equity plan
- Youth Council
- Community Forums
- Coaching
- Book studies
- Implementation of learning

Lincoln is excited to be a part of this learning as we continue to deepen our understanding of social justice, diversity, equity and inclusion and move our district forward in this work.



SOCIAL-EMOTIONAL LEARNING (SEL) PILOT GRANT

Social-Emotional Learning is part of MDE's Michigan Integrated Continuous Improvement Process (MICIP) and focuses on not just academics, but the whole child. Lincoln Consolidated Schools understands the importance of the social and emotional well-being of our students and staff. Due to this, we applied for a grant and were awarded the District-Wide SEL Pilot grant sponsored by MDE. We are in the second half of the sixteen-month Pilot which has supported us in scaling up SEL from a building to a district level. This year, our focus will consist of strengthening the SEL efforts within the district through:

- Adhering to the core components of CASEL's five SEL competencies through ongoing training and support
- Professional learning on approved district SEL resources that are differentiated to meet the needs of the staff and community
- Putting processes in place for how and when to use the SEL resources
- Ensuring that equity is inseparable from the five SEL competencies

Our district will end the pilot better prepared to take the work to full implementation.

Enrollments for grades K-12 are taken online at www.lincolnk12.org where you will also submit the required documentation to finalize your student's registration.

STUDENT ENROLLMENT DOCUMENTS

- Child's Birth Certificate
- Child's Immunization Record - current and up-to-date
- A well-check health appraisal (Kindergarten and Young 5 students ONLY)
- Transcripts (grades 9-12)
- Individualized Education Plan (IEP) and METS (if applicable)
- One of the following Proof of Residency in your name at your current address:
 - Current Tax Bill
 - Rental Agreement or Receipt
 - Mortgage statement/Purchase Agreement
 - Closing Statement
 - Utility Bill/Turn on Notice (water, gas, electric)
 - Voter ID

You can contact the Enrollment Office at enrollment@lincolnk12.org or call 734-484-7099 with questions.

If your family lives in any of the following situations:

- **In a shelter, motel, vehicle, or campground**
- **On the street**
- **In an abandoned building, trailer, or other inadequate accommodations, or**
- **Doubled up with friends or relatives because you cannot find or afford housing** you need

to know that preschool and school-aged children have certain rights or protections under the McKinney-Vento Homeless Education Assistance Act.

You have the right to:

- Go to school, no matter where you live or how long you have lived there. You must be given access to the same public education provided to other students.
- Continue in the school you attended before you became homeless or the school you last attended, if that is your choice and is feasible.
- Receive transportation to the school you attended before you became homeless or the school you last attended, if you request such transportation.
- Enroll in school without giving a permanent address. Schools cannot require proof of residency that might prevent or delay school enrollment.
- Enroll and attend classes while the school arranges for the transfer of school and immunization records or any other documents required for enrollment.
- Enroll and attend classes in the school of your choice even while the school and you seek to resolve a dispute over enrollment.
- Receive the same special programs and services, if needed, as provided to all other students served in these programs.
- Receive transportation to school and to school programs.

When you move, you should do the following:

- Contact the school district's local liaison for homeless education at 734-484-7070 for help in enrolling your child in a new school or arranging for your child to continue in his or her former school. (Or, someone at a shelter, social services office, or the school can direct you to the person you need to contact.)
- Contact the school and provide any information you think will assist the teachers in helping your child adjust to new circumstances.
- Ask the local liaison for homeless education, the shelter provider, or a social worker for assistance with clothing and supplies, if needed.



SCHOOLS VACCINES REQUIRED FOR SCHOOL ENTRY IN MICHIGAN

Whenever children are brought into group settings, there is a chance for diseases to spread. Students must follow state vaccine laws in order to attend school. These laws are the minimum standard to help prevent disease outbreaks in school settings. The best way to protect students in your care from other serious diseases is to promote the recommended vaccination schedule at www.cdc.gov/vaccines. Encourage parents to follow CDC's recommended schedule; by doing so, school requirements will be met.

Problem Solving: A Two-Way Process

Get Started

- Establish your goal.
- Agree to discussion guidelines.
 - Listen without interrupting.
 - Be honest in your discussions.

Listen and Define the Concern

- What is the problem or concern?
- Is there more than one perspective from which to view the problem?
- Is the information each person has about the problem accurate?

Identify Solutions

- Each person suggests at least one solution to the problem.
- All parties evaluate each possible solution:
 - Can all parties agree with the solution?
 - Is everyone committed to working on the suggested solution?
 - Will the solution work now and in the future?
 - Is everyone willing to share equal responsibility for making the solution work?
 - Does the solution tell who, when and how?

Move Forward

- Agree upon a proposed solution and the role each party will have in implementing it.
- Set a date for checking in with each other.

LINCOLN EARLY CHILDHOOD SERVICES

The Lincoln Early Childhood Center, located in Model Elementary School, offers a range of comprehensive services for children from birth through age five. The center utilizes a model that emphasizes that parents are a child's first, best, and most influential teachers.

The Early Childhood Center includes classrooms for the Great Start Readiness Program, Early Childhood Special Education, and Lincoln's Early On Program. The goal of the center is to establish a primary prevention community available to families living in the Lincoln community. Through strong parental involvement, the Early Childhood Center is an avenue promoting the improved social, cognitive, and physical growth of young children in our community.

Pre-School

Lincoln offers two different pre-school programs. Students for these programs must be three years old by September 1st and reside in the Lincoln School District. Great Start Readiness Program (GSRP) is a grant-funded pre-school program. Eligibility for this program is based on household income and a child's "risk factors." Welcome back to Lincoln Consolidated Schools for the 2022-2023 school year! For student safety, we do not publicly publish school bus route information.

REQUEST FOR STUDENT TRANSPORTATION

Lincoln Consolidated Schools requires a completed Request for Student Transportation form for each student (with the exception of ECSE & GSRP) needing school bus transportation. To request transportation for your child(ren), complete the online form (available online at www.lincolnk12.org) for each student.

Bus Transportation will only be assigned for students who have a completed request form on file. Transportation will be provided to/from one address. Families with multiple addresses will be responsible for getting students to/from the designated stop. Students without an assigned bus will not be allowed to ride the bus. Families will be notified of their bus route information prior to the start of school.



BUS RIDERSHIP PROGRAM

Transportation is using technology to increase safety and manage bus routing. Each student riding the bus will be given a transportation ID badge that they will need to scan on and off the bus daily. There is also a parent software application (HERE COMES THE BUS) for your devices to track the buses location individualized for your students. We understand that anything new will take some time to get into a routine and we will help you with the new processes.

PRESCHOOL/KINDERGARTEN STUDENT

For your child's safety, a parent/guardian or appointed emergency contact person (must be on the emergency card) MUST be at the bus stop to pick up your preschool/kindergarten student every day. Parents will be responsible for the costs associated with childcare for any student returned to campus.

COMMON STOPS & TRAVEL ZONES

The national bus driver shortage continues to impact the number of routes we can offer to our families. By increasing the distance families travel to common stops, we will be able to provide service to more families, at a reduced cost to the district. By following industry best practices adopted by our neighboring districts, families may need to travel a longer distance than in past years to their common bus stop.

Beginning in the fall, many of the current bus stops will be consolidated and as a result buses may not be entering some of our manufactured home communities, apartment complexes, or subdivisions. Common stops will be placed in these high density areas where families will be able to wait for their students to enter and exit the bus.

DAYCARE STOPS

Lincoln works with several approved area daycare centers to provide transportation. Families must have confirmation from daycare centers that they are registered before being routed on a bus. The daycare centers that will have a bus stop at the center are Teddy Bear Daycare, Happy Days Daycare, Dorothy's Daycare, and Stephanie's Daycare.

BUS STOP CHANGE REQUEST

Bus routes for the school year will be set no later than July 15 of each year. This will be based on the requests made by families for the upcoming school year and reviewed annually for the safest and most cost effective routes.

Requests for a bus stop change can be made in the Transportation Office. All requests will be researched and you will be notified of the results **within thirty days of the request**. Please be aware that all requests must meet the criteria for change and are not automatically honored.

BUS STOP CRITERIA

Our number one priority is the safe transportation of your child. The procedures we have in place are to make sure we can do so. Your understanding of the challenges we face and your part in making sure we are able to provide the safest and highest quality service possible is truly appreciated.

PERSONAL CURRICULUM ALTERNATIVE

Generally, to earn a high school diploma, a student must satisfy the requirements of Michigan's Merit Curriculum. The District may modify those requirements, however, by developing a personal curriculum for a student. All students are entitled to a personal curriculum.

A parent or guardian of a student who has completed ninth grade (or the student if at least 18 years old or emancipated), or a student's teacher or counselor, may request a personal curriculum by contacting the High School Principal. A group that includes the student; the student's parent or guardian; and a teacher, guidance counselor, or person acting in a counseling role, will consider the request. If the personal curriculum request is made by a student who is at least 18 or who is emancipated, or by a parent or guardian, the group will grant the request and will develop a personal curriculum for the student. For all other requests, the group will develop a personal curriculum if the group determines one is appropriate. For most students, the group that develops the personal curriculum may make only certain modifications to the Merit Curriculum.

For students with disabilities under the Individuals with Disabilities Education Act and for certain students transferring to the District from a nonpublic school or from out of state, the group may make additional modifications. For all students, a personal curriculum must incorporate as much of the Michigan Merit Curriculum content expectations as is practicable for the student, must include measurable goals for the student to achieve while in high school, must include a method to evaluate whether the student met those goals, and must align with the student's educational development plan.

Before a personal curriculum becomes effective, the High School Principal and the student's parent or guardian (or the student if at least 18 or emancipated) must agree to its terms. Once effective, the student's parent or guardian (or the student if at least 18 or emancipated) must communicate with each of the student's teachers to monitor the student's progress on the personal curriculum goals. A student who successfully satisfies his or her personal curriculum may earn a high school diploma even if the student does not otherwise satisfy all of the Michigan Merit Curriculum requirements.

INTEGRATED PEST MANAGEMENT NOTIFICATION

State of Michigan law requires that schools and day care centers that may apply pesticides on school or day care property must provide an annual advisory to parents or guardians of students attending the facility.

Please be advised that Lincoln Consolidated Schools utilizes an Integrated Pest Management (IPM) approach to control pests. IPM is a pest management system that utilizes all suitable techniques in a total pest management system with the intent of preventing pests from reaching unacceptable levels or to reduce an existing population to an acceptable level. Pest management techniques emphasize sanitation, pest exclusion, and biological controls. One of the objectives of using an IPM approach is to reduce or eliminate the need for chemical applications of pesticides. However, certain situations may require the need for pesticides to be utilized.

As required by State of Michigan law, you will receive advance notice regarding the non-emergency application of a pesticide such as an insecticide, fungicide, or herbicide, other than a bait or gel formulation, that is made to the school or day care grounds or buildings during this school year. Please note that notification is not given for the use of sanitizers, germicides, disinfectants, or anti-microbial cleaners. In certain emergencies, such as an infestation of stinging insects, pesticides may be applied without prior notice to prevent injury to students, but you will be notified following any such application.

Advance notification of pesticide applications, other than a bait or gel formulation, will be given by at least 48 hours to the application by the following two methods. The first method will be by posting at the main entrance to your school/day care center. The second method will be posting in a public, common area of the school or day care center, other than an entrance. We will post in your school's Main Office.. Please be advised that parents or guardians of children attending the school may review the school's Integrated Pest Management Program and records of any pesticide application upon request

Please be advised that parents or guardians of children attending the school or day care center are entitled to receive the advance notice of a pesticide application, other than a bait or gel formulation, by first class United States mail postmarked at least 3 days before the pesticide application, if they so request. If you prefer to receive the notification by first class mail, please contact your building/program administrator for a form and return it to our office.

Resident Membership – \$20/Month

Available to all members of the Lincoln Community – verified by an address within the Lincoln Consolidated School District boundaries. Resident pass members have access to the workout facility, and use of the fieldhouse track, turf, and batting cages when they are scheduled to be open to members. Resident pass members may add any children (Under 18) for an additional \$5/month.

Non-Resident Membership - \$40/ Month

Available to all applicants that are not members of the Lincoln Community. Non-resident pass members have all of the same access rights as Resident Pass members. Non-Resident pass members may add any children (Under 18) for an additional \$10/month.

Staff Membership – \$25/Year

The LCS Staff pass starts on August 1st and ends July 31st of the following year. It includes all regular membership rights. Spouses/partners of LCS Staff are eligible for membership at the Resident Pass purchase rate, regardless of residence. Staff members may add any children under the age of 18 for an additional \$5/month.

Student Membership – \$10/Year

The Student Pass starts on August 1st and end July 31st the following year. All students of the Lincoln Consolidated School district are required to purchase an annual student pass for access to the LAB. Students 15 & Under must be accompanied by a parent or coach to use the facility.

Daily Pass – \$8/Day

Visitors may purchase a daily member pass and enjoy membership benefits until the building's close of business that day

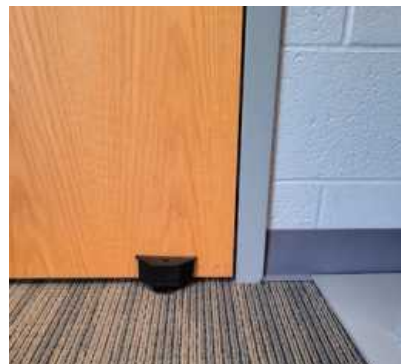
FACILITY AND TECHNOLOGY IMPROVEMENTS

In 2018, the community approved a \$25 million bond to improve facilities for athletics, fine arts, technology, security and more. The projects that have been completed include new choir and band spaces, new cheer space, new wrestling space, new weight room, one-to-one technology district-wide, Ben Q interactive boards in classrooms, performance space shell, and updated flooring in several buildings.



SAFETY & SECURITY

The LCS 2018 Bond and a grant secured from the Michigan State Police included several safety and security updates across campus. We have secured the main entrance to each school building, added security cameras across the district, added classroom door locking systems, and a corridor lock down system.



The LCS 2018 Bond allowed us to replace asphalt on RAILSPLITTER DRIVE, REMOVE AND REPLACE FENCING AROUND THE STADIUM COMPLEX AND BISHOP ELEMENTARY, IMPROVE PARKING LOT LIGHTING, ADD ADDITIONAL PARKING AT LHS/LAB, REMOVE AND REPLACE THE ROOFS AT BISHOP AND LHS, REPLACE THE CHILDS BUS LOOP, AND ADD PLAYGROUND EQUIPMENT AT BISHOP.





A LOOK INSIDE THE LAB

What is the LAB?

The LAB, short for the Lincoln Athletic Building, is a state-of-the-art training facility located in the heart of the Lincoln Consolidated Schools campus. The 118,000-square-foot building that voters approved as part of a 2018 bond features a 300-meter track with a pole vault pit and high jump area as well as a 90-yard artificial turf playing field lined for football, soccer, lacrosse and more. Plus, the facility houses a fitness facility for the public to use on a membership basis, with revenue offsetting expenses and supporting the school district.

In addition to providing indoor practice space for Lincoln Railsplitters athletics teams, community recreation, and community education programs, the new indoor athletic facility is also available for private rentals. Lincoln has partnered with Total Sports to provide rental services in sports that include soccer, softball, lacrosse, baseball and football, generating revenue in the facility right away.



The LCS 2018 Bond allowed for the creation of a state-of-the-art baseball/softball complete featuring cloverleaf fields and a concession stand. Additionally, the stadium was outfitted with Lincoln blue and gray turf and track.



2018 BOND UPDATE

FAMILY EDUCATIONAL RIGHTS AND PRIVACY ACT ANNUAL NOTIFICATION OF RIGHTS & DESIGNATION OF DIRECTORY INFORMATION

Each year the Lincoln Consolidated School District is required to give notice of the various rights accorded to parents or students pursuant to the Family Educational Rights and Privacy Act ("FERPA"). Parents and eligible students have a right to be notified and informed. In accordance with FERPA, you are notified of the following:

- 1. RIGHT TO INSPECT:** You have the right to inspect and review substantially all of your education records maintained by or at the Lincoln Consolidated School District. This right extends to the parent of a student under 18 years of age and to any student age 18 or older.
- 2. RIGHT TO REQUEST AMENDMENT:** You have the right to seek to have corrected any parts of an education record which you believe to be inaccurate, misleading or otherwise in violation of your rights. This right includes the right to a hearing to present evidence that the record should be changed if a designated official of the Lincoln Consolidated School District decides not to alter the education records according to your request. If no change is made to the education record after the hearing, you have a right to place a written rebuttal in the record.
- 3. RIGHT TO PREVENT DISCLOSURES:** You have the right to prevent disclosure of education records to third parties with certain limited exceptions. It is the intent of the Board of Education to limit the disclosure of information contained in your education records to those instances when prior written consent has been given to the disclosure, as an item of directory information of which you have not refused to permit disclosure, or under the provisions of FERPA which allow disclosure without prior written consent.
- 4. RIGHT TO COMPLAIN:** You have the right to file a complaint with the United States Department of Education concerning the alleged failure of the Lincoln Consolidated School District to comply with FERPA. Your complaint should be directed to:

- 5. RIGHT TO OBTAIN POLICY:** You have the right to obtain a copy of the policy adopted by the Board of Education in compliance with FERPA. A copy may be obtained in person or by mail by contacting the office of the Superintendent.
- 6. RIGHT TO OBJECT TO RELEASE OF DIRECTORY INFORMATION:** Generally, school officials must have written permission from the parent of a student or an eligible student before releasing any information from a student's record. However, FERPA allows school districts to disclose, without consent, "directory" type information. The Board of Education of the Lincoln Consolidated School District has designated the following personally identifiable information contained in a student's education record as "directory information":
 - Student's name
 - Address
 - Telephone number
 - Picture
 - Parent or guardian
 - Date and place of birth
 - Height & weight
 - Major field of study
 - Dates of attendance or grade placement
 - Honors and awards received
 - Participation in and eligibility for officially recognized activities and sports
 - Most recent educational agency or school attended by the student

Unless you advise the District that you do not want any or all of this information released, school officials may release the personally identifiable information it has designated as directory information. Upon such objection, this information will not be released without the prior consent of the parent or eligible student.

You have three weeks from the receipt of this notice to advise the District in writing of any or all of those types of information about the student you refuse to permit the District to designate as directory information. Your objections should be addressed to the respective building principal. Completing this form will provide written notification to the District and this information will not be released without the prior consent of the parent or eligible student.

TALK: TEXT AND LEARN FOR KINDERGARTEN

- Parents and caregivers can sign up to receive text messages offering simple activities to improve their children’s literacy. The statewide service, called TALK (Text and Learn for Kindergarten), sends two text messages a week suggesting activities that parents and caregivers can easily incorporate into daily routines with their children.
- Parents may sign up by texting **TALK to 75547** or visiting **texttolearn.com**. The texts are available in English or Spanish.
- Each message begins with one of the five early literacy practices and details an activity parents can use to help their child develop early literacy skills, which are reading, singing, talking, writing, and playing. The texts go beyond literacy and help parents build other important skills such as premath and social emotional skills. The more parents and caregivers talk and listen to young children, the easier it is for them to learn to read and write when they start kindergarten. This is because simple activities such as singing and playing every day help kids develop the cognitive and language skills they need to do well in school.
- TALK is available to parents and caregivers in Michigan with children ages 5 years and younger.
